Additional amenities include a parking driveway, a backyard, a large storage area, a heat room with natural gas heating, and a wooden fire escape extending from the fourth floor to ground level. Located in a vibrant community, the property is within walking distance to Tropicana Casino, the Boardwalk, the beach, public transportation, shopping centers, fine dining, and nightlife. It is also close to major attractions such as \"The Walk\" (Tanger Outlets), Boom Market, Atlantic City Convention Center, and Boardwalk Hall.
